and binding services in China signifies the fact that the operational activities mentioned above are quite popular among the Chinese people even in the current scenario.




Figure 1: Revenue of Stitching and Binding services in China




Figure 2: Revenue from Book Binding services in China




Figure 3: Revenue of the Graphical Services




Figure 4: Chinese stitch binding




Figure 5: Binding process
